Sub: - **Last minute cancellation of the transfer order of Shri Sushil Kumar Kashyap, JE, from Haryana circle to UP (East) circle – requesting for your kind intervention – req.**

We wish to bring the following to your kind notice for favour of information and for making necessary intervention.

Shri Sushil Kumar Kashyap, JE, was transferred under Rule-8, from Haryana circle to UP (East) circle, vide CGM, Haryana letter no.HRCO-11/20(12)/6/2020-HR AND ADMIN/132 dated at Ambala the 29.07.2022.

The aforementioned transfer order was issued by the CGM, Haryana circle, based on the consent given by the CGM, UP(East) circle, for accommodating Shri Sushil Kumar Kashyap, JE, in UP (East) circle. The consent of the CGM, UP(East) circle, was communicated vide letter no.Staff/M-28/JE/Transfer/IC/2021/5/39 dated 04.09.2020.

The official, Shri Sushil Kumar Kashyap, JE, was relieved vide letter no.SDE(G)/NGH/Genl/2021-22/37 dated 16.08.2022. However, when Shri Sushil Kumar Kashyap reported in the CGM office, UP (East) circle, he was not permitted to join duty in UP (East) circle. The official has been informed that, the consent letter given by the UP (East) circle has already been cancelled.

Subsequently, the CGM, Haryana circle, vide letter no.HRCO-11/20(12)/6/2020-HR AND ADMIN/135 dated at Ambala the 17.08.2022, has cancelled the transfer order issued to Shri Sushil Kumar Kashyap, JE, from Haryana circle to UP (East) circle.

It is needless to state that, the official, Shri Sushil Kumar Kashyap, JE, will be undergoing enormous stress and mental agony on account of cancellation of his transfer order and that too, after reaching CGM, UP (East) office for joining duty. It is important to note that, the transfer order has been issued by the CGM, Haryana circle, after obtaining the due consent of the CGM, UP (East) circle. But, we are at loss to understand, why the CGM, UP(East) has cancelled the consent given for the transfer under Rule-8 of Shri Sushil Kumar Kashyap, JE, in the last minute.

In view of the foregoing, we request you to kindly intervene in this matter and to do the needful, so that Shri Sushil Kumar Kashyap, JE, could join duty in UP (East) circle.
