Sub: Making posts available for promotions-Management adopting of two different yardsticks for the Executives and Non-Executives, resulting in huge loss to the prospective JTO LICE candidates-reg.

Ref: BSNLEU Letter No. BSNLEU/526 (JTO) dated 13.06.2022

I am directed to refer to your letter dtd 13.06.2022 on the subject cited above. In this regard, it is intimated that your grievance has been examined and the following is intimated:

1. The vacancies notified vide Rectt Branch letter dated 21.04.2022 specifically belong to the vacancy year 2021 only as per the number of post available in BSNL in JTO(T) grade subsequent to the Restructuring exercise approved by BSNL Board.

Vide this office letter dated 11.05.2022 (enclosed) which is reiterated in your letter dated 13.06.2022 at para 3 wherein it was informed that a total No of 4687 JTOs(T) were promoted to SDEs(T) during calendar year 2021 and working strength of JTO(T) as on 31.12.2021 is (14733-4687) 10046. As such, total net vacancy arise during calendar 2021 is 1710 (11756-10046, where 11756 is the JTO(T) all India sanctioned strength] out of this LICE vacancy is 889 (including vacancy that arose due to death /retirement/ VR/ resignation etc). Since only 18 circles had vacancies, LICE has been notified only for these circles and hence all the vacancies arising due to promotion of JTO(T) to SDE during calendar year 2021 have been considered.

BSNL has held JTO (T) LICE separately for vacancy years 2013-14, 2014-15, 2015-16, 2016-17 and 2017-18. The abolition of large number of posts in BSNL through VRS, retirement and Restructuring exercise approved by BSNL Board rule out any utilization of posts that may have been available in the year 2018 and 2019 and which are non-existent now.



2. Recently, BSNL has issued a letter no. BSNLCO-A/16(27)/21/2022-ESTAB dated 15.06.2022 for holding **Special** JTO(T) LICE 2022 on Pan India basis wherein all eligible candidates of all 28 recruiting circles are allowed to apply for this exam with option for successful JTOs to opt for any one of deficit circles.

This is issued with the approval of the competent authority.
