Sub: - Non-granting of meeting to the district union of BSNLEU, by the GMTD, Ludhiana – req.

Ref: - BSNLEU letter no. BSNLEU/ 323 (PJB) dated 14.09.2021.

As regards the state of affairs in Ludhiana SSA of Punjab circle, we wish to bring the following to your kind notice for favour of necessary action.

It has been brought to our notice that, meeting is not being granted to the district union of BSNLEU, by the GMTD, Ludhiana. The district union of BSNLEU, Ludhiana district, vide it's letter no.BSNLEU/LD/ORG/2021 dated 28.08.2021, has submitted agenda items for discussion and has sought for a meeting with the GMTD, Ludhiana. The receipt of this letter has duly been acknowledged by the GMTD office (copy enclosed).

However, despite the lapse of more than one month, no meeting has been granted to the district union of BSNLEU, by the GMTD, Ludhiana. Nor, any date has been fixed for the meeting. BSNLEU is the Main Recognised Representative Union in BSNL. Similarly, Ludhiana is also a very big SSA in Punjab circle. As such, denial of meeting to the district union of BSNLEU has created a stalemate in the redressal of grievances of the employees.

In this connection, we would also like to bring to your kind notice that, the circle secretary, BSNLEU, Punjab circle, has met the CGMT, Punjab circle, five times and has requested him to intervene in the issue of non-granting of meeting, by the GMTD, Ludhiana. The CGM, Punjab circle, had been assuring that, necessary advice would be given to the GMTD, Ludhiana. However, on 04.10.2021, the CGM, Punjab circle, has told that, he would not talk to the GMTD, Ludhiana and has advised the union to give a letter in this connection, which, he assured to forward to the GMTD, Ludhiana. From the foregoing, it is also clear that, the CGM, Punjab circle, does not intend to intervene in this matter.

Under these circumstances, I earnestly urge upon you to kindly intervene on this matter and to ensure that, necessary instruction is sent to the GMTD, Ludhiana, for granting meeting to the district union of BSNLEU.
