We wish to bring the following to your kind notice, for favour of necessary action.

Late Shri C Pandu Ranga Rao, TT, Ananthapur got electrocuted while attending to a cable fault and has tragically passed away on 10-10-2020. The death of the official has occurred while he was on duty.

Since the death of Shri C Pandu Ranga Rao, TT, has occurred while he was on duty, the CGM, Andhra Pradesh has recommended Compassionate Ground Appointment to Smt.C.Manjula w/o late Shri C Pandu Ranga Rao, TT. Copy of the letter of the CGM, Andhra Pradesh is enclosed for your kind perusal.

It can be seen from the letter of the CGM, Andhra Pradesh circle, which is cited under reference (1), the case for granting of Compassionate Ground Appointment has been sent to the Corporate Office on 12-03-2025.

We wish to point out that, late Shri C.Pandu Ranga Rao, TT, was the sole breadwinner of his family. After the demise of Shri C.Pandu Ranga Rao, TT, his family is undergoing severe financial crisis. In this connection, your kind reference is also invited to the Corporate Office letter cited under reference (2), which categorically states that, in case of death due to accident while performing duty, the dependent of the diseased official should be directly given Compassionate Ground Appointment, ignoring the weightage points.

In view of the foregoing, we request you to kindly look into the case and to do the needful, so that Smt.C.Manjula w/o late Shri C Pandu Ranga Rao, TT is expeditiously considered for Compassionate Ground Appointment.
