Sub: - **JTO LICE to be held for the VY-2022 – discrepancy in calculating the vacancies of Rajasthan circle - requesting to examine the same - reg.**

Ref: - **SNATTA letter no.SNATTA/RAJ/2023-24/4 dated 09.05.2023**

With reference to the letter cited above, we wish to draw your kind attention to the following, for favour of necessary action.

Vide letter no.BSNLCO-11/13(12)/2/2023-RECTT-CO dated 16.05.2023, the Recruitment Branch has issued notification for holding the JTO LICE (50% quota) for the VY-2022. In Annexure-A of this letter, the vacancies existing in various circles up to 31.12.2022 are given. As per this Annexure-A, the number of vacancies existing in Rajasthan circle are shown as only 4 (OC-2 ; SC-1 ; ST-1).

In this connection, the Circle Secretary of SNATTA, Rajasthan circle, vide letter number cited under reference has pointed that, the vacancies falling under 50% LICE quota in Rajasthan circle comes to  $63/2=31.5$ . In justification of this figure, the Circle Secretary, SNATTA, Rajasthan circle, has enclosed copies of the JTO(T) to SDE(T) promotion orders (copies enclosed).

However, we wish to bring to your kind notice that the Rajasthan circle administration has not looked into the matter and taken appropriate corrective measure. Hence, we earnestly request to you to kindly look into the letter cited under reference and to do the needful for rectifying the mistakes that have occurred in the calculation of JTO LICE vacancies in Rajasthan circle. We hope that necessary remedial action will be taken at earliest.

**Sub: Promotion of JTOs(T) to SDE(T) in BSNL against 67% seniority-cum-fitness quota(Promotion quota)-reg.**

In pursuance to BSNL CO, ND letter No. BSNLCO-PRII/13/11/2020-PERS-II(Part-4) dated 30.12.2021, the Executives in the cadre of JTO(T), as per the details in enclosed Annexure-I, is hereby promoted and posted against 67 % seniority-cum-fitness quota (Promotion quota) to SDE(T) in the IDA Pay Scale of Rs 20600-46500 on regular basis with effect from the date they assume charge of the higher post and until further orders, provided that :

- i. No disciplinary/vigilance case is pending against him/her and VC is not withheld in terms of instructions contained in GOI(DoP&T)OM No. 22011/4/91-Estt.(A) dated 14.09.1992, and also other relevant instructions.
- ii. The currency of any penalty against the officer is over.
- iii. The officer is not on deputation to any other organization.
- iv. The officer has not resigned/VRS/Taken VR/Expired/ retired/Already promoted on the date of issue of the order.
- v. They have fulfilled the prescribed eligibility of three years regular service as per SDE(T) RR.

2. Further, the executives are promoted to SDE (T) subject to their Vigilance clearance to be ascertained by the respective BA/Units. In case VC of any executive falls within the instructions contained in DoP & T order dated 14.9.1992 as referred above or is under currency of penalty, his/her promotion order may not be given effect and information in this regard may be brought to the notice of this office immediately along with the details of prosecution/suspension/disciplinary Case/under currency of penalty, if any as the case may be. Such cases may be kept as in "Deemed sealed cover."

3. Any JTOs (T) in Annexure-I, if DoT optee should not be promoted and such cases should be reported to this office.

4. All BA/Unit Heads concerned may ensure that the promotion/posting orders in respect of officers are issued in time to enable the officers to join their promotional assignment, within the prescribed time limit of 40 days (including the joining time).

5. In case the officer concerned fails to join the promotional assignments within the prescribed period of 40 days from the date of issue of this order, he/she should not be allowed to join the post thereafter. In such a situation, the promotion order shall become inoperative and such cases shall be reported to this office. Further, no request for modification of posting order shall be entertained.

6. BA/Units concerned are further advised that the pendency of request of the officer for modification of the promotion/posting order should not be taken as ground for holding up the implementation of the promotion order in respect of the officer.

7. The leave, if any requested by the officer, who has been posted on promotion, should not be allowed. If any officer desires leave, he/she can apply for leave to new place of posting under whom he/she has been posted only after joining the new assignment. The new controlling officer will sanction leave, if it is considered justified as per norms.

8. Any discrepancy in name of the executive, gender, present circle, DOB, HRMS Number etc. in the Annexure may be intimated to this office immediately for issuing necessary correction. However, they may be allowed to join the promotion post in the present BA/unit.




