Sub: - **Inadvertent mistakes committed by 3 candidates of Tamil Nadu circle in filling up TT LICE and JE LICE applications – requesting to take remedial action as requested by the CGM Office, Tamil Nadu circle - req.**

Sir,

We wish to bring the following to your kind notice for favour of information and necessary action.

Our Tamil Nadu circle union has brought to our notice that, some inadvertent mistakes have taken place in the filling up of applications for TT LICE and JE LICE by some candidates in Tamil Nadu circle. The Tamil Nadu CGM Office has sent an e-mail to the Recruitment Branch on August 16, 2024, seeking remedial actions in this connection. The details are as follows:-

- (1) Shri Muruganathan, ATT, Per No.00000336, working in Coimbatore BA, applied for TT LICE. However, the application was registered in the JE LICE. ***This official wants to appear in the TT LICE only.*** Hence, needful remedial action may kindly be taken.
- (2) Shri Velmurugan S, Per No.701596, is a TT. While filling up the application, the official has inadvertently applied for TT LICE, instead of JE LICE. ***The official wants to appear in the JE LICE only.*** Hence, needful action may kindly be taken to allow him to appear in the JE LICE.
- (3) Shri V. Kannusamy, TT, Per No.00400272, Erode BA, has inadvertently applied for TT LICE, instead of JE LICE. ***The official wants to appear in the JE LICE only.*** Hence, needful action may kindly be taken to allow this official to appear in the JE LICE.

Copy of the e-mail of the CGM Office, Tamil Nadu circle, cited under reference, is enclosed for your kind perusal. We request you to kindly help the officials so that they can appear in their desired LICES.

Sir, In respect of Tamilnadu Circle, some candidates have wrongly applied for TT exam instead of JE exam, and some have applied for JE exam instead of TT exam. They have further applied for the correct exam second time and the system allowed the same. However, the same is not appearing in the respective e-verification list ( for respective advt. date). The following are the details of the candidates:

1. Candidate Name: Murugananthan, ATT, Per No.00000336, working in Coimbatore BA. The official has applied for the LDCE exam. But instead of ATT to TT, the application was registered in the JE LDCE by mistake by the official. He subsequently applied for TT LDCE also. Both the copies are attached herewith. While doing IR-Verification in SAP-ERP, his name was reflected in the JE list only. Hence his application was under the Not eligible category in SAP-ERP. The official is requesting to consider his request to allow him to write the LDCE ATT to TT . As per SAP he had passed the 10th exam in 2018 and his DOB is 04/04/1981.  
**Candidate name should appear in TT LICE.**

2. Candidate Name: Sri Velmurugan S ( Per no: 701596 ) TT , has inadvertently applied TT LICE exam instead of JE LICE exam. Necessary correction may be done pl.  
**Candidate name should appear in JE LICE.**

3. Candidate Name: Sri V Kannusamy TT, Per No. 00400272 of Erode BA applied for TT exam instead of JE exam. The official is eligible for JE exam however, the e-verification for the candidate cannot be done as he wrongly applied for TT exam.  
**Candidate name should appear in JE LICE.**

Kindly arrange to resolve the issue so that their names are reflected in the respective exams.
