Sub: - **Deliberate harassment of BSNLEU's members in Bijnore OA of UP (West) circle, by enforcing deduction of monthly union subscription at exorbitant rate – requesting to fix responsibility and to take action against the officer who is brazenly violating Corporate Office order - req.**

Madam,

With reference to the letter cited above, we wish to bring the following to your kind notice for favour of necessary action.

Vide letter cited under reference, the Corporate Office has issued letter to all the Chief General Managers regarding deduction of union monthly subscription for the members of BSNLEU. As per this letter, the monthly union subscription of BSNLEU has been fixed at Rs.70/-. It is already more than 3 years since this letter has been issued by the Corporate Office.

Recently, it has been brought to our notice that, in Bijnore OA of UP (West) circle, the monthly union subscription of the members of BSNLEU is being deducted at the rate of Rs.115/-. We are enclosing copy of the pay slip of Shri Neelkamal, JE, Bijnore, for information. This is not only surprising, but is also shocking. The action of the district administration of Bijnore is in total violation of the Corporate Office letter cited under reference.

It has been brought to our notice that, deduction of union monthly subscription at the rate of Rs.115/- is being done with the malafide intention of harassing the members of BSNLEU. Deducting of monthly union subscription at the rate of Rs.115/-, in the place of Rs.70/- is being done with the ulterior motive of creating anger and resentment among the members of BSNLEU, against the Union. We also have reason to believe that, this is being done to drive members of BSNLEU away from the Union, so that they can become members of other unions.

There is reason for us to believe that, whomsoever is responsible for this action, is doing this deliberately, to weaken BSNLEU. Hence, we request you to kindly make intervention on this issue, so that the exorbitant amount being deducted in the name of monthly union subscription of BSNLEU, is stopped forthwith. We also request that, responsibility may kindly be fixed on the officer who is deliberately harassing members of BSNLEU and suitable action may kindly be initiated against them.
