Sub: - **Suppression of facts and furnishing of false report to the Corporate Office, by the DGM (Fin/IFA), O/o CGMT, HP circle, Shimla, with regards to the grievance of Shri Vivek Kanwar - req.**

Sir,

We wish to bring the following to your kind notice for favour of necessary action.

We have already brought to the kind notice of the Management regarding the grievance of Shri Vivek Kanwar, an SC candidate of Himachal Pradesh, who has been deprived of his JAO promotion, due to the non-carrying forward of the unfilled SC vacancies for the JAO LICE conducted in 2016.

In this connection, we are informed by the then PGM(EF) that, necessary details have been called for, from the CGM Office, Himachal Pradesh circle. In this connection, we wish to bring to your kind notice that, the DGM (Fin/IFA), O/o CGMT, HP circle, Shimla, has sent a false and misleading report to the Corporate Office, vide letter cited under reference (1).

In this letter, the DGM (Fin/IFA), O/o CGMT, HP circle, Shimla, has stated that, there were 6 SC vacancies for the JAO LICE conducted in the year 2012 and that, all the 6 SC vacancies have got filled up. This is totally a false and fabricated statement.

In this connection, we wish to draw your kind attention to the statement sent to the Accounts Officer (SEA), CGM Office, Shimla, by the ADT (HR), CGM Office, Shimla, on 08.04.2013, cited under reference (2). A copy of this statement is enclosed for your kind reference. It is stated in this statement that, there were 4 SC unfilled vacancies in the JAO LICE held from 17th to 19th December, 2012. It is also found from this letter that, totally 6 SC officials have qualified in the JAO LICE held from 17th to 19th December, 2012. In this, 4 SC candidates have passed on their own merit and hence they were promoted against OC posts. Only 2 SC candidates have got promoted against SC posts. This has been done correctly, in accordance with the DoP&T instructions which state that, SC / ST officials who pass on their own merit, should be promoted against OC posts.

In our letter addressed to the PGM(EF), BSNL CO., we have stated that there were 6 SC vacancies for the JAO LICE conducted in 2012, against which only 2 SC candidates were promoted and the balance 4 vacancies remain unfilled. It is our complaint that these 4 unfilled SC vacancies were not carried forward for the JAO LICE conducted in 2016, as a result of which, Shri Vivek Kanwar, an SC candidates, has been deprived of his JAO promotion. The statement of the ADT (HR) has vindicated our stand. A copy of this letter of the ADT (HR) is enclosed for your kind perusal.

From the above documents, it is proved that the DGM (Fin/IFA), O/o CGMT, HP circle, Shimla, has wantonly sent a false report to the Corporate Office. It is needless for us to state that, suppression of facts and furnishing of misleading official report is violation of the rules.

In view of the foregoing, we request you to kindly look into this issue and to take necessary action.
