Sub: - **False report sent to the Corporate Office, by the CGM Office, Himachal Pradesh, in the matter of denial of JAO promotion to the SC official of Himachal Pradesh circle – reg.**

Comrade,

We wish to draw your kind attention to the subject mentioned above.

As you are aware, CHQ is continuously taking up with Corporate Office, the issue of denial of JAO promotion to Shri Vivek Kanwar of Himachal Pradesh circle. Due to the efforts taken by the CHQ of BSNLEU, the SEA Branch of the Corporate Office called for the details regarding the unfilled SC vacancies of the JAO LICE conducted in the year 2012.

The DGM (Fin./IFA), O/o the CGMT, HP circle, Shimla, vide letter no.Fin/SEA/2-4/T&P/JAO/VIII/150 dated 05.03.2025, has sent a false and misleading report to the Corporate Office, stating that all the 6 SC posts for the vacancy year 2012 have been filled up in the JAO LICE held in that year.

Whereas, in the report sent by the ADT (HR), O/o the CGMT BSNL, HP circle, vide letter no. HRD/R&E/Ex-279/JAO Part-II (40% quota)/62 dated 08/04/2013, **it is clearly stated that 4 SC vacancies remained unfilled in the JAO LICE conducted in 2012.**

Thus, it become clear that the DGM (Fin./IFA), O/o the CGMT, HP circle, has suppressed the facts and has sent a false and misleading report to the Corporate Office.

Yesterday itself, the CHQ has already written a complaint in this connection to the PGM(SEA), Corporate Office, New Delhi. However, it is very clear that, the Corporate Office cannot do anything unless a correct report is sent from the CGM Office, Himachal Pradesh circle.

**In view of this, I request you to kindly discuss the issue once again with the CGM, HP circle. In case, needful action is not taken by the administration, then necessary trade union action may be launched by the circle union of BSNLEU.**
