Sub: - **Corrupt practises of Shri. Mansur Alam Toppo, AGM(CFA), Meerut and deterioration of industrial peace and staff relations in Meerut - requesting for your kind intervention – req.**

Sir,

We wish to draw your kind attention to the sorry state of affairs prevailing in Meerut OA of UP (West) circle.

Ever since Shri Mansur Alam Toppo joined as the AGM(CFA), Meerut, industrial peace and staff relations have started deteriorating. He behaves rudely with his subordinate staff and keeps them threatening. It may not be out of context here to mention that, there were several vigilance cases against Shri Mansur Alam Toppo in the past. We learn that, there are some cases at the present also.

Matters changed from bad to worse, when Shri Mansur Alam Toppo started extracting money from his subordinate officers like SDEs. Further Shri Mansur Alam Toppo is also extracting money from the vendors. BSNLEU, Meerut District Branch, has given written complaint to the administration, regarding the corrupt practices of Shri Mansur Alam Toppo. This infuriated Shri Mansur Alam Toppo and he started victimising our people. The matter was discussed with the DGM, Meerut BA and also with the GM (HR) Meerut circle, but situation never improve.

Hence, the Meerut district Union started organising lunch hour demonstrations, demanding action against Shri Mansur Alam Toppo. These demonstrations were organised peacefully only during the lunch hours and without causing any disturbance or dislocation to the services.

However, the peaceful demonstrations organised by members of BSNLEU have been taken very seriously by Shri Mansur Alam Toppo and he started taking revenge against members of BSNLEU. For instance, Shri Mansur Alam Toppo has imposed dies-non for six days, i.e., from 12-02-2025 to 17-02-2025, against Shri Ashwin Kumar JE (FTTH), Meerut. It is very relevant to mention here that, the SDE, FTTH, under whom Shri Ashwin Kumar JE (FTTH) is working, has submitted a detailed report to the AGM (CFA) on 23- 03-2025, wherein he has certified that, Shri Ashwin Kumar JE(FTTH)has been on duty on all the days. (A copy of this statement is enclosed for your kind perusal).

It is to be clearly mentioned here that, Shri Mansur Alam Toppo is out to disturb industrial peace and staff relations in Meerut OA, since his corrupt practices have been questioned by the district union of BSNLEU. It is also worth mentioning here that, the circle administration has formed a committee consisting of two DGMs, to probe into the complaints levelled against Shri Mansur Alam Toppo. However, even under this circumstance, Shri Mansur Alam Toppo is harassing our employees by issuing dies-non, memo, etc.

It is unfortunate that, the issue could not be discussed with the CGM, UP (West) circle, since he mostly remains in Lucknow. Hence, the issue could not be resolved at the CGM level. It is under these circumstances that, we are compelled to bring the matter to your kind notice, we request you to kindly look into the matter and to ensure that, appropriate action is taken against the corrupt practices of Shri Mansur Alam Toppo and also that, industrial peace and staff relations are restored in Meerut OA.
