Sub: - <u>Holding of lunch-hour demonstrations on 26-04-2022, protesting against the discrimination in promotions</u> <u>between the Executives and the Non-Executives and demanding to hold the JTO LICE and other LICEs of</u> <u>the Non-Executives with the posts that existed up to 31-01-2020 - reg.</u>

Ref: - BSNLEU letter no. BSNLEU/526 (JTO) dated 22.04.2022.

We wish to draw your kind attention to the following, for favour of appropriate action.

The BSNL management has issued notification to hold the JTO LICE on 07-08-2022. The candidates who have been waiting to appear in this JTO LICE are shocked because, there are no vacancies in 11 circles and only a few vacancies are there in 9 more circles. The same is going to be the fate in respect of the forthcoming JE LICE, JAO LICE, TT LICE, etc.

BSNLEU, vide letter cited under reference, has already invited your kind attention to this issue. This problem has arisen mainly because of the unrealistic Restructuring of Manpower, put in place by the BSNL Board. Without taking into account the requirements of the Organisation, thousands of posts have been abolished mechanically.

Further, it is noticed that, pending the completion of the Restructuring Process, the JTO to SDE promotions have been implemented, taking into consideration the posts that existed prior to 31-01-2020. However, the JTO LICE is going to be held with the posts in accordance with the Restructuring of Manpower. *This is a blatant discrimination between the Executives and Non-Executives of the Company.*

Hence, BSNLEU has given call to organise lunch our demonstrations on 26-04-2022, demanding to hold the JTO LICE to be held on 07-08-2022, with the posts that existed up to 31-01-2020 and also to hold all the forthcoming LICEs of the Non-Executives, including the JE LICE, JAO LICE and the TT LICE, with the posts that existed up to 31-01-2020.

We request you to kindly revisit this issue and to render justice to the Non-Executives of the company.
