Sub: - **Payment of the arrears of the IDA increase w.e.f. 01.10.2020, 01.01.2021 and 01.04.2021 for the Non-Executives of BSNL- req.**

Ref: - **(1) Hon'ble High Court of Kerala order in the W.P.(C) No.26423 of 2020(C) dated 17.12.2020.**
(2) DPE letter no.W-02/0002/2014-DPE(WC)-GL-III/2021 dated 02.08.2021.

We would like to draw your kind attention to the order of the Hon'ble Kerala High Court, cited under reference (1), for favour of necessary action.

The DPE vide it's letter no.W-02/0039/2017-DPE(WC)-GL-XVI/20 dated 19th November, 2020, has frozen the increase in the IDA of the Executives and Non-Unionised Supervisors of the CPSEs, for the period from 01.10.2020 to 01.07.2021.

You are aware that, BSNLEU filed a writ petition in the Hon'ble High Court of Kerala, with prayer to declare that, the aforementioned DPE order to freeze the IDA, was not applicable to the Non-Executives of BSNL. Accordingly, the Hon'ble Kerala High Court, vide it's order cited under reference (1), has held that, the IDA freezing is not applicable to the Non-Executives.

Thereafter, with the view to implement the above mentioned order of the Hon'ble Kerala High Court, BSNLEU wrote to the DPE, requesting to communicate the exact percentage of IDA increase, that has become due w.e.f. 01.10.2020. However, the same was not communicated by the DPE.

Now, the DPE, vide it's letter cited under reference (2) has notified the details of the IDA increase that has become due w.e.f. 01.10.2020, 01.01.2021 and 01.04.2021. In view of the foregoing, we earnestly urge upon you to kindly ensure that the arrears of the IDA increase w.e.f. 01.10.2020, 01.01.2021 and 01.04.2021 are paid to the Non-Executives of BSNL without further delay.
