Sub: - **Posting husband and wife in the same station – requesting to take a onetime decision to approve the pending transfer applications to Surplus circles - req.**

(2) BSNLEU letter no.BSNLEU/510(T&P) dated 27.10.2023.

With reference to the letters cited above, we wish to once again draw your kind attention to the above mentioned subject.

The DoP&T, vide letter cited under reference (1), has categorically stated that the husband and wife should be posted in the same station. This instruction has been issued by the Government, keeping into account the difficulties being faced by the husband and the wife in getting posted in the same station.

In BSNL, the above mentioned DoP&T order is not being implemented. A good number of JEs, who have completed more than 5 years of service, have applied for transfer to join their spouse. But, these transfers are not being allowed to circles categorised as "Surplus", in respect of JE cadre.

BSNLEU, is repeatedly knocking the doors of the BSNL Management for the implementation of the above cited DoP&T order in letter and spirit. BSNLEU, vide letter cited under reference (2) has requested the Management to mitigate the sufferings of the employees due to non-getting of transfer under spouse ground, in accordance with the DoP&T order cited above. BSNLEU has also taken up this issue in the Formal Meeting held with the Director (HR) on 19.03.2024.

Under the above mentioned circumstances, BSNLEU once again urges upon you to kindly revisit the issue and to take a ***onetime decision for approving all the pending applications of JEs, seeking transfer to the "Surplus" circles.*** Your kind response to our request will help the re-union of a number of dedicated employees, who are suffering due to non-getting of transfers to their desired circles.
