Sub: - **Problem faced in applying Rule 8 transfer - seeking your kind intervention - req.**

We wish to bring the following to your kind notice for favour of necessary action.

Time and again, BSNLEU is writing letters to the BSNL Corporate Office regarding the difficulties being experienced by DR JEs in getting Rule 8 transfers to their native places. The Corporate Office has also taken certain measures to mitigate those difficulties. Hereunder, we bring one such case which requires your kind intervention.

Shri Amit Kumar Tiwari, DR JE, (HRMS No.60160052), Meghalaya BA in NE-I circle has applied for Rule 8 transfer on 11.05.2022, to CNTx North Circle. On the date when Shri Amit Kumar Tiwari applied for Rule 8 transfer, CNTx North Circle was a shortage circle. However, subsequently CNTx North Circle has become a Surplus Circle and requests of DR JEs who have applied for Rule 8 transfer to that circle are not being considered.

It is needless for us to mention that Shri Amit Kumar Tiwari has served in a difficult and far-flung area like Meghalaya and has applied for Rule 8 transfer on completion of 5 years of service. It is already more than one year, since the official has applied for Rule 8 transfer and still he has not got the transfer since CNTx North is a Surplus Circle.

Considering the sufferings being faced by the DR JEs who is posted in a far-flung and hard areas, we earnestly urge upon you to kindly find out remedial measures. Since there is no possibility for Shri Amit Kumar Tiwari to get his Rule 8 transfer to CNTx North Circle, alternatively, the official may kindly be considered for Rule 8 transfer to Madhya Pradesh circle, based on the seniority of the date on which he applied for transfer to CNTx North circle, i.e., 11-05-2022. A copy of the representation of the official is enclosed for your kind perusal.

Subject: Technical roadblock in getting rule-8 transfer from NE-I to CNTx-North in JE cadre-Reg.

Respected Sir,


This is to bring your kind attention towards the difficulty faced by me in getting rule-8 transfer from NE-I (Surplus) to CNTx-North despite applying in a shortage circle obeying the corporate office guidelines. I hail from Prayagraj but I couldn't apply in UPE circle as it was categorised as surplus. So, I applied in CNTx-North as it was declared as shortage circle by letter no BSNLCO-A/15(14)/1/2022-ESTAB dated on 17.06.2022. After a long period of nearly one year, when my accommodation was recommended by NE-I circle it was not accepted by the CNTx-North citing the reason that it has already met its sanctioned strength, which is a technical roadblock as the status of this shortage circle got changed during the long journey of my rule-8 request.

There are examples where such roadblocks have been avoided by giving option for station change in circles like Gujrat and Assam. In NE-I circle (Meghalaya BA), I am waiting for my transfer for more than one and half year despite applying in a shortage circle, while my juniors are getting transfer in other circles.

I, therefore, earnestly request to your good office to kindly intervene in this matter and allow me one option to go to Madhya Pradesh circle(Shortage as for now) with my same seniority position giving the effect to the corporate office guidelines in true sense i.e. transfer from surplus circle to shortage are to be done on priority in the interest of service.
