Sub: - **Holding of a Special JTO LICE for the Draughtsmen cadre of Civil wing - reg.**

Sir,

We wish to bring the following to your kind notice for favour of necessary action.

As you are aware, BSNLEU is continuously taking up the issue of conducting a Special JTO LICE for the Draughtsmen of the Civil and Electrical wings. In this connection, the CGM(BW) is kind enough to send vacancy particulars to the Recruitment Branch for holding the Special JTO LICE.

The issue is discussed with the PGM(Rectt.) by our Union today. During this discussion, it was pointed out by the PGM(Rectt.) that, there is no provision in the current JTO RR for holding a Special JTO LICE. In this connection, we wish to draw your kind attention to the minutes of the 28th meeting of the National Council, held on 30th January, 2013, issued vide Corporate Office letter no.BSNL/39-3/SR/2012 dated 3rd April, 2013, para 8.2.14 of the said minutes reads as thus:-

8.2.14 Restructuring of Civil Wing.

Staff Side requested one more JTO examination may be conducted for the Draughtsman who could not appear in the JTO examination against the 50% quota conducted in the year 2008, as they had not completed 10 years of service at that time.

Management Side replied that the case for grant one more chance for Draughtsman (Civil/Elect/Telecom) to appear in JTO (Civil)/JTO (Elect.) was considered by Director (HR) and it was agreed to give one more opportunity to Draughtsman cadre on the similar lines as given on previous occasion. The case is under active consideration by the Branch for seeking approval by the competent authority.

In the year 2008, a Special JTO LICE was conducted for those Draughtsmen who had completed 10 years of service. Thereafter, the Union demanded that one more examination should be conducted for the left out Draughtsmen, i.e., for those who had not completed 10 years of service at the time when the Special JTO LICE was conducted in the year 2008.

We wish to point out that, the examination conducted in the year 2008 was done by relaxing the JTO RR. In the similar manner, now also, the Special JTO LICE for the Draughtsmen of the Civil and Electrical wings has to be conducted by relaxing the JTO RR. Certainly, the Management is having necessary power to give such a relaxation.

From the minutes quoted above, it is clearly recorded "*that the case for grant of one more chance for Draughtsmen (Civil/Elect./Telecom to appear in JTO (Civil / JTO (Elect.)) was considered by Director (HR) and it was agreed to give one more opportunity to Draughtsmen cadre on the similar lines as given on previous occasion.*"

In view of the foregoing, we request you to kindly initiate necessary action for holding the Special JTO LICE for the Draughtsmen of the Civil wing, by relaxing the JTO RR.
