Sub: **Denial of the facility of immunity from transfers – case of Shri Shakeel Ahmed Siddiqui, District Treasurer, BSNLEU, Jabalpur, Madhya Pradesh circle – requesting for your kind and expeditious intervention - req.**

We wish to bring the following to your kind notice for favour of necessary action.

It is reported by the Circle Union of BSNLEU, Madhya Pradesh circle that, the facility of immunity from transfer has been denied to Shri Shakeel Ahmed Siddiqui, District Treasurer of BSNLEU, Jabalpur.

Shri Shakeel Ahmed Siddiqui has been transferred to a rural area, 40 km away from Jabalpur. This is violation of the Corporate Office instructions on the facility of immunity from transfer, extended to the Main Recognised Trade Union. It is needless for us to state that, this transfer will seriously affect the functioning of the District Union of Jabalpur. It is further reported that, the facility of immunity from transfer has been denied to Shri Shakeel Ahmed Siddiqui, based on the Corporate Office letter no.BSNL/20-4/SR/2022 dated 14.10.2022.

It is obvious that, the aforementioned Corporate Office letter on the facility of immunity from transfers, has been issued in respect of Recognised Association and Support Association of the Executives. The terms and conditions, laid down in this Corporate Office letter are applicable only to the Executives' Associations and not to the Recognised Trade Unions of the Non-Executives.

The matter has been taken up with the Madhya Pradesh circle administration by the Circle Union of BSNLEU. However, the matter has not been resolved at the circle level also.

In view of the foregoing, we are bringing the case to your kind notice for favour of necessary intervention by the Corporate Office. We earnestly request you to kindly intervene in this matter and to ensure that the facility of immunity from transfer is granted to Shri Shakeel Ahmed Siddiqui, District Treasurer of BSNLEU, Jabalpur.
