Sub: - **Waiving of the pension contribution in respect of Shri Swapan Chakraborty, OS(P), who was on foreign service with BSNLEU – req.**

We wish to bring the following to your kind notice for favour of necessary action.

The BSNL Corporate Office, vide it's letter cited under reference (2), has conveyed the approval of the Competent Authority, for waiving the pension contribution of the office bearer, who is on foreign service with the Recognised Union. This letter of the BSNL Corporate Office has been issued in accordance with GOI order, issued vide MOF OM No.F.1(10)-E.III(B)/75 dated 20.10.1975.

Shri Swapan Chakraborty, OS(P) of NE-I circle, is the Deputy General Secretary of BSNLEU and was on foreign service, working in the Head Quarters of BSNLEU at New Delhi. As such, the pension contribution in respect of Shri Swapan Chakraborty, should have been waived in accordance with the BSNL Corporate Office letter number cited under reference (2).

However, it seems, the same has not been done. As a result of this, the pension settlement of Shri Swapan Chakraborty, who retired on superannuation on 30-04-2020, has not been done.

Further, the CCA, North East circle, vide his letter cited under reference (1), has written to the district administration of Agartala, NE-I circle, has directed to submit the approval of the DoT (Head Quarters), for the waiving of his pension contribution for the period from 01.04.2015 to 31.01.2020, i.e., the period during which Shri Swapan Chakraborty, was on foreign service with BSNLEU.

In view of the foregoing, we request you to kindly look into the matter and to take the necessary action expeditiously, so that the waiving of the pension contribution, in respect of Shri Swapan Chakraborty, is done in accordance with the provision contained in the letter cited under reference (2) and also for the communication of the same to the CCA, North East circle.
